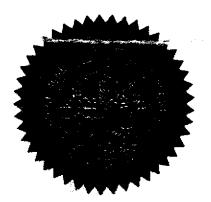

ARTICLE I - NAME

The name of this Corporation shall be the "DON CE-SAR PROPERTY OWNERS CORPORATION". Its location shall be 3516 E. Maritana Drive, Don Ce-Sar Place, St. Petersburg, Florida.

ARTICLE II - OBJECT
