Raising the Sail!

The DCPOC Board has set several objectives regarding Blocks M and N.

- To preserve, in perpetuity, the designation of Blocks M and N as private property for the owners of the approximately 300 properties of Don CeSar Place;
- To prevent/enjoin any further transfers of ownership rights of Blocks M and N;
- To remove Blocks M and N from legal limbo;
- To enable DCPOC to take necessary steps to limit access to Blocks M and N to only those property owners and their guests which may include, but is not limited to, the ability to post signs, erect barriers, install access controls, etc.;
- To limit, to the greatest degree possible, the legal liability of the organization, its directors and officers, and all property owners: and
- To minimize the ongoing costs for items such as insurance, legal fees, etc.

/// FUNDRAISING

After several weeks of due diligence, meetings with the City of St Pete Beach, and meetings with legal counsel, the Board has concluded the need to protect Blocks M and N through continuing the legal proceedings to obtain title of Blocks M and N. As such, there are immediate costs associated with the legal proceedings and placing the property into a Trust to ensure it is preserved for the benefit of all property owners.

The sail is set at \$25,000 and we need your help Raising the Sail!



Flooding Committee

The committee continues to communicate to the city the importance of improving the impact of stormwater and tidal flow in our neighborhood. At the April 27th commission meeting, a presentation by the DCPOC flood committee and 176 petition signatures from Don CeSar residents implored the city leadership to immediately complete the planned work on the spillways in Don CeSar Place (stormwater drainage, tide flex valves, and seawall reconstruction) to prevent tidal flow into the neighborhood. The DCPOC flooding committee wanted hard deadlines to get work done to protect our subdivision.

On June 8, 2021, the commission approved for Rowland Inc. 36th Avenue baffle box Installation under the existing On-Call Civil & Large Pipeline Contractor Services Agreement, in the amount of \$147,833.74, for the installation of the 36th Avenue Baffle Box.

The City issued a Request for Bids (RFB) in May of 2021 for the 2021 Seawall & Stormwater Improvements-Don CeSar Place Neighborhood project. These repairs, which will be performed on the stormwater outfalls in the Don CeSar neighborhood, include seawall, stormwater and roadway repair or replacements at 7 locations throughout the neighborhood. In response to this RFB, the City received three (3) bids from qualified contractors. The base bid from Construct Company, Inc. was the lowest responsible bid at \$627,246.00 and has been determined to meet all the requirements outlined in the issued solicitation. Construction is anticipated to take 150 calendar days to complete, with an expected start date in July of 2021. This approval includes 15% contingency in addition to the \$627,246.00 bid amount from Construct Company, Inc. for a total authorization of \$721,332.90. Approval for this bid was made on June 22, 2021.

Residents should soon be seeing work on all the spillways along Maritana and the 36th/Casablanca baffle box. The flooding committee will surely keep on top of the work plan and deadlines set.



Seawall Height Ordinance

The city approved the Seawall Height Ordinance on May 25, 2021. This is not a mandate and is only applicable when a property owner needs to repair/replace their seawall; this is a minimum rebuild standard.

Parking Committee

Ken Folsom met with Community Policing Deputy Patrick Krager on June 6th to relay community concerns raised and discussed at the DCPOC Parking Committee meeting, DCPOC General Meeting, and St. Pete Beach Government/DCPOC telephone conference. Please remember, the primary parking concerns center on The Don Vista, El Centro, Casablanca, Lazarillo Park, The Community Seawalls & the Public Boat Ramp. We have established an inclusive and thorough process of gathering resident concerns and communicating them to policy makers/enforcers. We look forward to scheduling a DCPOC Parking Committee meeting and initiating a new round of productive contacts. *A Don CeSar Place Parking Guide is available for download at www.dcpoc.org.*

Bylaws Committee

The Bylaws Committee has completed drafts of the new bylaws and corporate charter and has submitted them to the Board for its review. The new versions are intended to give members a stronger voice in the DCPOC and close some gaps in the current governing documents. After Board review, the Committee will make any necessary refinements and circulate the revised, as well as current, versions to members for their review. Because many people are not here during the summer months, proposed bylaws and charter will be circulated to all members in the Fall.

Historic Preservation: An Update

The City has received notice that the Department of State's Division of Historical Resources has awarded us the \$50,000 historic preservation grant the City applied for last year. The



grant will allow for a survey/inventory to be conducted of the Don CeSar Place Subdivision. Since our City is a Certified Local Government, no dollar match is required on our part.

Further details are expected soon from the State historic preservation office.

DCPOC NEWS

Working with the City of St. Pete Beach

The DCPOC Board continues to work with the City of St Pete Beach on many issues that are important to the neighborhood. Much of the work is discussed in the Committee News section of the newsletter. Additionally, the City will be conducting a study of traffic through our neighborhood to determine measures that can be put into place to cut down on speeding. The City has changed the boat ramp hours from closing at 11pm to closing at 10pm. The City confirmed that no wedding permits will be issued along Blocks M and N and it will be up to DCPOC to determine whether weddings will be permitted.

DCPOC had further discussions with the City about code enforcement issues and the exhaustive approach for residents to use the SeeClickFix app. In the future, enforcement officers will be assigned to specific zones in the city so they can actively inspect for and act upon violations. The City provided additional contact information. See the box at right.
