

A Tribute to Jim Breslin

As a young man, Jim Breslin moved to the Breslin home, on South Maritana Drive. There were only 3 or 4 houses on the entire block at that time. His family had recently relocated from New York State where his Dad, James, Sr., had practiced medicine and his mom, Irene, had worked as a nurse. Jim soon entered Military Service and told wonderful tales of his days stationed in Colorado. Never one to miss an opportunity, Jim enrolled at St Pete Junior College and parlayed those years into a degree from USF.

At USF, Jim contracted what he termed a life-long case of Malearia, when he met and married Marie Malear, the glue that held his family together for 60 years. His eldest son, Jimmy, was followed by daughter Kristine Melody. With a young family to support, Jim took a job as a Claims Adjuster at Allstate Insurance. It was then that he took to sailing, later joining the Gulfport Yacht Club and becoming a mainstay at club functions.

Being a Claims Adjuster led him to law school at Stetson University and a great and lengthy career as a trial attorney, specializing in workers' compensation and personal injury law. He also served as an unpaid counselor to many friends, neighbors and family members.

Realizing the value of community service, Jim was active with the Don CeSar Property Owners Corporation from close to the time of its inception as an organization and before that when we were a small group of neighbors meeting informally, often at Jim's home. Jim preferred working behind the scenes, often performing tasks and helping others without revealing his identity.

As his family grew, so did his home on South Maritana, where Marie maintained fabulous plantings to delight the entire neighborhood. While continuing to enjoy sailing, Jim took on another hobby: hunting. He spent many a weekend at his beloved camp, seldom killing anything (or anyone!) but building another group of close-knit friends. His Boat Parade Parties were legendary. The guest list was all encompassing and he and Marie welcomed everyone who showed up, invited or not!

The news of his illness was devastating but Jim continued to soldier on for the benefit of the neighborhood, remaining active in the DCPOC despite his diagnosis. After a long and hard fought battle against unwinnable odds, Jim passed away on September



20, 2022. His wonderful wife, Marie, and three of his four children were by his side. His oldest daughter, Kristi, was en route from New Zealand when Jim breathed his last breath. Jim was also the extraordinarily proud and loving grandfather of six amazing grandchildren.

A Memorial Service will be held on Thursday, January 4, 2023 at 2:30pm at Bay Pines National Cemetery (10000 Bay Pines Blvd, St. Petersburg) followed by a Celebration of Life at the Gulfport Yacht Club (4638 Del Rio Way S, Gulfport).

2023 Membership Dues



M&N Stewardship Committee

Each of us now formally has rights to the private beach lots known as parcels M and N. Now that DCPOC has title to the properties, a number of important and complex items have to be addressed and the M&N Stewardship Committee has been hard at work on them. The committee has provided input on the commercial use agreements we are working on with the two hotel properties that are part of Don Cesar Place. Additionally the M&N Stewardship Committee has researched and recommended a rational, uniform approach to signage that helps to protect our private property. The issues surrounding these properties are significant and involve a number of stakeholders; of course decisions to be made require the input of the residents so look for us to solicit your opinion and feedback in the weeks ahead.

Flooding Committee

On September 12, 2022, during the St Pete Beach Budget Workshop, the City Commission voted to reallocate \$780,000.00 towards flood mitigation in the Don Cesar Place neighborhood. The City Commission recognized, after a plea from our President Betty Rzewnicki, the many issues and failures that have been occurring along the spillways. The city will be meeting with the DCPOC Flooding Committee to discuss a plan on addressing the flooding and how to best use the funds set aside.

The committee has also been searching for additional funds to help support a living shoreline project in the neighborhood. We reached out to Tom Reis with Environmental Science Associates, ESA, to evaluate the seawalls throughout the neighborhood. Tom was able to coordinate a meeting with the Tampa Bay Estuary as a potential funder to the project. We were fortunate the Flooding Committee, City of St Pete Beach and Tampa Bay Estuary met and discussed applying for funds by the end of this year for the engineered plans on building a living shoreline for the neighborhood. We hope to build this public private partnership in hopes to protect the neighborhood from ongoing flooding.



/// Protect St. Pete Beach

The Protect St Pete Beach committee's main goal is to protect the quality of life of St Pete Beach residents, to protect us from overdevelopment, to protect St Pete Beach from becoming the next Clearwater Beach, Daytona, or Miami. Our Island cannot handle any more traffic. Our streets, our infrastructure, and our resources are strained to the limit.

The Protect St Pete Beach committee has been working to fund independent studies, by independent firms that residents can trust, rather than a firm that the developers also use. The Protect St Pete Beach committee has conducted independent traffic studies and we have engaged the services of attorneys, consultants, and planners with a proven track record of standing up for residents' rights rather than lobbying for developers.

St Pete Beach is on the verge of multiple massive hotel expansion projects. When do we stop and say enough is enough?


